

Nebraska PDMP Pharmacies & Other Dispensers –

The Nebraska PDMP is in the process of converting to a new PDMP vendor. This will entail changes to the process of submitting data to the PDMP. The following information provides guidance on preparing for the upcoming changes.

Important Dates to Remember:

- We need your help! We need several uploaders to be ready to send to the new uploader site starting August 5, 2019.
 - If you are interested in becoming an early adopter of the new PDMP data submission process, please contact us at pdmp@nehii.org
- All uploaders will send to the new uploader site starting September 3, 2019
- All users will start viewing patient information in RxGov in September, 2019

Change of Uploader Submissions:

- Please! Whitelist (blocking program settings in your email and web browser) for the new RxGov website and email addresses to prevent them from being blocked or lost in Junk or Spam mail.
 - o You will receive emails from RxGovHelp@egov.com
 - You will manage your account, view patients and access the Submitter Portal at http://nepdmp.rxgov.com
 - You may need to contact your internal or corporate IT support to prevent these from being blocked in your system (e.g., mark as Not Junk, Do Not Block Domain).
 - o You will connect SFTP file managers to sftp-nepdmp.rxgov.com (Port 177330)

Uploader Account:

- Between August 5 and September 3 you will need to create a new Uploader (Submitter) account with RxGov.
 - This is a great opportunity to ensure Nebraska PDMP has your latest and most accurate information as we set you up on the new platform.
- o Please note that for RxGov your user name will be your email address.
- DO NOT ATTEMPT TO CREATE YOUR SUBMITTER ACCOUNT PRIOR TO AUGUST 5.

- Included with this notice are the parts of the Nebraska PDMP Data
 Submitter Registration and Implementation Guide that you will need to start the process.
