RE: Support SB714 Expanding Access to Care through Pharmacy Healthcare Destinations

Chairwoman Harrell and Members of the Senate Health Policy Committee:

On behalf of our members operating in the state of Florida, the National Association of Chain Drug Stores (NACDS) offer our support for SB714 related to expanded pharmacist authority to test and initiate treatment for influenza. We applaud the Senate Health Policy Committee for recognizing the tremendous value this legislation will provide to Floridians in receiving increased access to convenient and affordable quality care.

Sixteen (16) states currently already allow pharmacists to offer this valuable service, with additional states such as Colorado and Texas underway with similar efforts in this space. With over 20% of outpatient antibiotic use deemed as inappropriate, ii test and treat services provided by pharmacists support community antibiotic stewardship efforts. Research has shown that patients often first visit their pharmacy with the flu and other minor ailments; iii and it shows that pharmacists are able to effectively adhere to evidence-based protocols and guidelines/standards of care to initiate appropriate therapy to those who test positive or provide necessary linkage to care to those in need of further evaluation. iv Expanded ability to test and treat allow pharmacists to alleviate the overwhelming time constraints other healthcare providers face, so that they can spend more time with complex patients.

Given the importance of enhanced delivery of quality healthcare, NACDS strongly urges the Florida Senate Health Policy Committee to vote "Yes" on SB714. Passage of this legislation will provide tremendous benefits to patients, employers, and the overall state healthcare system.
