Re: Practice of Pharmacy into Nevada

**Executive Secretary Wuest:** 

NRS 639.100(1)(a), as amended by Senate Bill 408, now states in pertinent part that it is "unlawful for any person to dispense<sup>1</sup> or compound<sup>2</sup> any prescription of a practitioner, unless the person holds the appropriate certificate, license or permit required by this chapter or chapter 453 or 454 of NRS." NRS 639.100(1)(a) operates in conjunction with NRS 453.371(2),<sup>3</sup> NRS 453.377(1),<sup>4</sup> NRS 454.215(1),<sup>5</sup> NRS 639.015,<sup>6</sup> and NRS 639.284(2),<sup>7</sup> to require any pharmacist compounding or dispensing any prescription for a controlled substance or dangerous drug for a patient located in Nevada to be registered with the Board.<sup>8</sup>
