RE: Over-the-Counter (OTC) Home Testing for COVID-19

EFFECTIVE: Immediately

The purpose of this informational letter is to provide guidance to providers on billing for OTC home testing for COVID-19. This policy will remain in effect for the duration of the public health emergency (PHE).

As part of the American Rescue Plan Act of 2021 (ARPA), Iowa Medicaid will provide members access to OTC home testing for COVID-19. This coverage differs from requirements under commercial plans in that there will be no reimbursement directly to Iowa Medicaid members who purchase the tests. All tests must be obtained and billed through a provider.

Providers who can bill as durable medical equipment (DME) providers (including pharmacies) on a CMS-1500 medical claim will be able to provide and bill for OTC tests using the HCPCS code T5999 (supply, not otherwise specified). No prescription will be required. No prior authorization is needed for FFS or in-network Managed Care Organization (MCO) providers.

Members will be limited to one (1) unit per member per day, and up to four (4) units per member per 30 calendar days. This limit is a combined maximum for the member cumulatively across all billing providers. One unit = one kit. Reimbursement will be up to

\$25.00 per kit. Both OTC antigen tests and polymerase chain reaction (PCR) tests, that are FDA-approved, will be covered.

Providers should bill the MCOs and FFS for OTC home tests in accordance with their medical benefit policies and procedures, using the appropriate electronic submission standards.
