**RE:** Hope and Opportunity in Many Environments (HOME)

**EFFECTIVE:** Upon Receipt

HHS is working to ensure that Iowa Medicaid members have access to high-quality behavioral health, disability, and aging services in their communities.

A new initiative, called HOME, began with a collaboration between community partners at Mathematica and the Harkin Institute who evaluated community-based services and published a final evaluation report<sup>1</sup> outlining recommendations for how HHS can improve available services. Based on these recommendations, the team created a transformation plan<sup>2</sup> to guide next steps and implement suggested improvements.

Through HOME, HHS recognizes the hope that comes with individuals being able to choose where they live and the services they receive. This makes maintaining health, social connection, and quality of life possible.

HHS is committed to bringing hope in the knowledge that seniors, individuals with disabilities, and individuals with behavioral health needs are connecting with the people they love in their homes and communities.

The voices of those receiving community-based services (CBS), their caregivers, and providers are vital in helping to guide a better system for everyone.

HOME will be implemented in phases through the end of 2024. Community members, caregivers, and providers are encouraged to share their thoughts during virtual and in-person
