ID# 529408 FY24 RFP 58824024 Adolescent Well Visit Pilot Project:** The purpose of the Request for Proposal (RFP) 58824024 is to solicit applications that will enable HHS to select the most qualified applicant to provide peer-to-peer practice consultation with PCP in Iowa to increase access and quality of adolescent well visits through long-term practice changes.
- 2. ID# 529412 FY24 RFP 58824022 Adolescent Mental Health Pilot Project:** The purpose of RFP 58824022 is to solicit applications that will enable HHS to select the most qualified applicant to provide peer-to-peer practice consultation with PCP in Iowa to increase PCP's ability to manage adolescent mental health in the primary care setting through long-term practice changes.
