## Re: Support for SB 1214 – Expand Public Access to Pharmacy Test-and-Treat Services

Dear Senator Bolick and Senator Carroll,

The National Association of Chain Drug Stores (NACDS) is writing in support of SB 1214 – important legislation supporting public access to routine healthcare services through community pharmacies. This bill will enhance healthcare options and capacity across the state by allowing pharmacists to offer basic testing and the initiation of treatment for common health conditions such as flu, strep throat, and other respiratory diseases – streamlining the process for people to receive convenient care.

Research on pharmacist-led "testing and treatment" demonstrates unequivocal patient safety, adherence to evidence-based guidelines, and cost-effectiveness.<sup>1</sup> Pharmacists' education and clinical training prepare them well to perform basic patient assessments and implement evidence-based treatment. During the recent public health emergency, pharmacy interventions averted over 1 million deaths, over 8 million hospitalizations, and saved approximately \$450 billion in healthcare costs.<sup>2</sup> The accessible and convenient pharmacy experience has cemented Americans' reliance on community pharmacies for "test and treat" services. States like Idaho, Alaska, and Colorado have already authorized the types of "test and treat" pharmacy services that would be allowed under SB 1214.

Importantly, the people of Arizona support the policies<sup>3</sup> in SB 1214:

- 85% of adults in Arizona say pharmacists are easy to access, the highest percentage of the tested options.
- **78%** of adults in Arizona believe it's important for their state to update its policies to ensure that patients permanently have the same **access to pharmacy vaccination, testing, and treatment** services that were available during the COVID-19 pandemic.
- **73%** of adults in Arizona support pharmacists **testing for and treating common illnesses** like flu and COVID; **70%** support testing for and treating common minor ailments such as strep throat.
- **71%** of adults in Arizona support private and government insurers **adequately paying pharmacists** for testing and initiating treatment in states where pharmacists are authorized to do so.

In summary, pharmacies remain a critical access point for many Americans to receive essential healthcare services – including across medically underserved areas, and among both rural and urban communities. Permanently authorizing pharmacy personnel to deliver "test and treat" services for flu, strep, and other respiratory conditions
